## Catholics say NO to killer jab

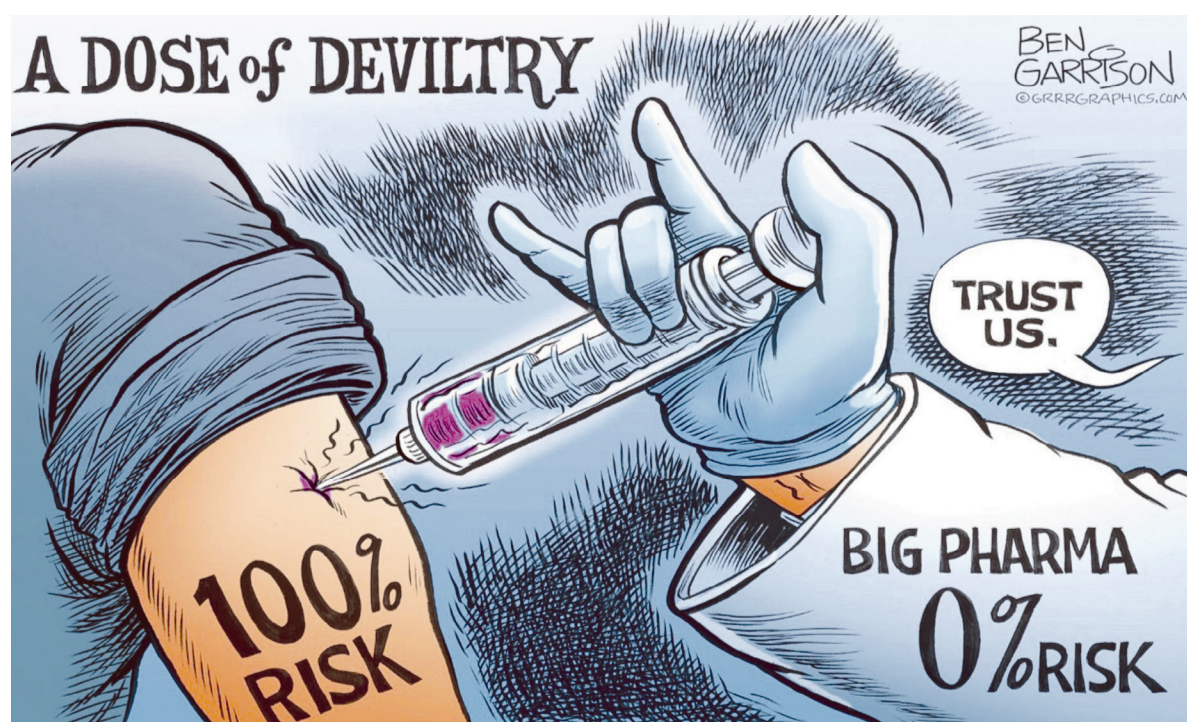
A revolt is stirring among Irish Catholics who are increasingly angered by the behaviour of bishops and priests who have been pushing the state's dangerous 'vaccine' programme from the pulpit.

**WHILE IN THE UK, 1,250 Christian clergy - including Catholic priests - have signed an open letter to Boris Johnson warning that the 'introduction of vaccine passports would constitute an unethical form of coercion' the Irish hierarchy seek to shepherd their priests and faithful in the opposite direction.**

This pattern, which began in December 2020, has escalated as the state becomes more and more aggressive, cynically targeting children as the schools prepare to reopen.

The bishops should be up in arms about this but instead there are innumerable reports of priests making pro-vaccine sermons, dismissing long-held ethical objections to the use of aborted materials in vaccine development, and informing their congregations that they have a 'moral responsibility' to 'protect the community' by being 'vaccinated' for Covid-19, despite this condition carrying virtually no risk for the vast majority of people, and no risk for children.

There is a growing sense that the Irish hierarchy, in lockstep with Pope Francis and the Vatican 'lavender mafia', is functioning more as an outpost of the New World Order than the voice of Jesus Christ in Ireland.

In December 2020, the Irish Catholic Bishops Conference welcomed the 'encouraging' news that a number of vaccines for Covid-19 were at an advanced stage of preparation and likely to be available soon. They said that the Church recognised that safe and effective vaccination was 'an essential aspect' of preventing disease, and that the refusal to accept a Covid-19 vaccine 'could contribute to significant loss of life in the community'.

In fact, other than mendacious governmental propaganda, there is still no scientific proof that Covid-19 exists, never mind that it has 'contributed to significant loss of life' in Ireland. The excess deaths statistics for 2020 show it had the lowest mortality rates for several years.

It is now well-established that authorities in Ireland and elsewhere have engaged in massive fear-mongering, using an inappropriate method - the PCR test, which is incapable of accurately detecting or measuring a virus - as well as falsifying

death registrations, to exaggerate or misrepresent what was happening.

In all of this deception, the authorities have had the unanimous backing of the Catholic bishops, who meekly closed their churches during lockdown and abandoned the Catholic population to an unprecedented denial of the sacraments and, in many instances, to terrifying lonely deaths.

Bishops have failed to inform the faithful that the Covid-19 'vaccines' are not vaccines at all, but DNA-altering injections brought to market on an experimental basis without proper testing. They have not told them about the many eminent scientists including Dr Robert Malone, the inventor of the mRNA technique being used to produce several of these 'vaccines', who have said they are dangerous and unsuited to the purpose they are being used for.

On the contrary, Catholic clerics continue to bully their congregations with spurious theological principles, implying that they have a 'moral responsibility' to accept the vaccines unquestioningly, failing to inform them that Church teaching allows for conscientious objection on several

grounds, including the question of the 'tainted' pedigree of vaccine materials, and the absence of any evidence that the alleged disease being 'vaccinated' against represents any real danger to public health.

The bishops also failed to tell their congregations that a recent supposed change in the Church's position on 'tainted' vaccines came about as a result of Pope Francis's gerrymandering of the Pontifical Academy for Life. Back in 2015, the pope fired the existing academy en bloc and replaced it with a collective heavily representing the views of the abortion industry and Big Pharma.

In their December 2020 statement, the Irish Catholic bishops claimed that '[i]f a more ethically acceptable alternative is not readily available to them, it is morally permissible for Catholics to accept a vaccine which involves the use of foetal cell-lines, especially if the potential risk to life or health is significant, as in the case of a pandemic. Refusal to accept a vaccine could contribute to significant

### DRUG-PUSHING FROM THE PULPIT

Parishioners at the Dominican Friary of St Saviour's in Dublin's inner city were horrified by a recent sermon extolling the virtues of Irish bishops and suggesting their word should be interpreted as divine law, especially in relation to 'vaccines'.

Some in the congregation were aghast to hear the priest go on to say that Catholics should ignore 'conspiracy theorists' and listen only to what the bishops have to say on the matter.

Yet the bishops collectively, who appear more like salesmen for criminal drug companies, subject Catholics to incessant moral blackmail on the matter.



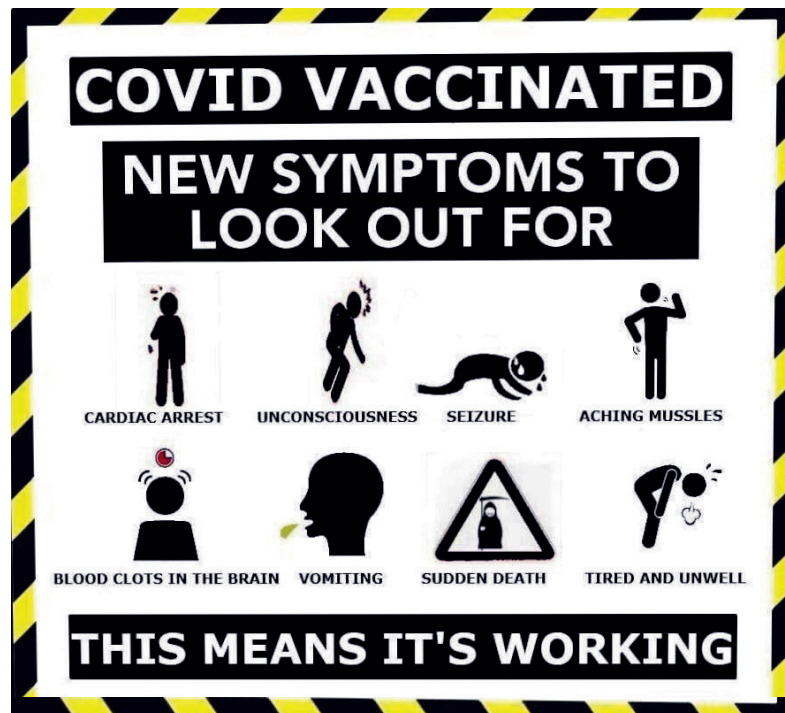
# HSE gave ‘Death Row’ sedative to ‘Covid’ patients

A powerful sedative administered to inmates on Death Row before execution to depress breathing was given to Irish people with Covid-19.

The Irish Light has uncovered a disturbing HSE document

**‘COVID-19 HSE Clinical Guidance and Evidence/ Syringe Pump Prescribing in the Last Hours or Days of Life’ which recommends the use of the drug Midazolam on people with the highly treatable common cold Coronavirus.**

Midazolam, which is twice as powerful as Valium, can suppress breathing and temporarily stop it leading to permanent brain injury or



death. It should only be prescribed, if ever, in very strict circumstances where a dying patient is in extreme pain and has no hope of recovery. Its use on patients with curable respiratory infections such as Covid-19 poses grave ethical dilemmas and raises concerns that the HSE gave it to patients to hasten deaths and boost Covid statistics.

A scandal surrounding the drug erupted in Britain in recent months when it was revealed that hospitals were using it on Covid patients as a means of euthanasia, with credible reports of tens of thousands of elderly people being killed by the drug in nursing homes.

This practice evolved out of the notorious Liverpool Care Pathway

scheme introduced in NHS hospitals in the late 1990s with the facade of providing ‘death with dignity’ and improving quality of care in the final days of a patient’s life.

Dubbed a one-way path to death, it was subsequently exposed as a means of shortening life in the sick and elderly through the use of dangerous sedatives like Midazolam and denying food and drink. It later emerged that many of the hospitals involved in the monstrous project had received financial incentives to meet certain death ‘targets’.

Hospital whistleblowers in Ireland have reported terrifying accounts of cruelty in wards during Covid with patients having swabs forced up their noses and being injected with the vaccine in their dying days. Could it also be the case that managers expedited death with the use of sedatives?

The HSE document gives an impression that Covid-19 is a terminal disease, even though it has a 99.96% survival rate and is easily treated with safe medications like Ivermectin and Hydroxychloroquine.

The HSE also claims that Covid hastened the deaths of many old people in April 2020 but could it have been Midazolam that actually caused them?

We know that at the start of the Covid deception last year, the government emptied the hospitals of thousands of sick and elderly people.

A HSE memorandum to GPs on March 21 instructed them not to carry out tests on people in homes and to assume that “if one resident at the nursing home had Covid-19, they all have it.”

Nursing homes were told to prescribe Midazolam and to pressurise relatives into going along with DNR (Do Not Resuscitate) notices.

There are many unanswered murky questions. How many people died as a consequence of government/NPHET actions?

Was Midazolam given to people with Covid respiratory conditions who were not dying at the time but subsequently did? Were any post-mortems or toxicology tests performed on the deceased?

ACI made an FOI (Freedom of Information) request to the HSE in June of this year seeking details of hospital usage of Midazolam, and to distinguish its use between Covid and non-Covid patients.

The HSE said it was unable to provide a response to our query claiming no such records exist.

loss of life in the community, especially among those who are most vulnerable. This reality must inform any judgement of conscience.’

This statement is chock-full of evasive phrases and weasel words. The bishops offered no evidence of any ‘significant’ or ‘potential’ risk to life or health commensurate with the ethical objection to tainted vaccines, as the Church’s teaching, correctly conveyed, requires them to do. The reference to ‘pandemic’ sidesteps the fact that the World Health Organisation has redefined this concept in a manner that no longer requires any evidence of fatalities, an unprecedented and deeply worrying development that the bishops have had nothing to say about. The sole reference to ‘conscience’ in the statement sought to twist the provision in Church teaching that permits Catholics to make their own ethical decisions on vaccines based on private conscience.

The assertion by the bishops

that a refusal of ‘vaccination’ could contribute to significant loss of life in the community and especially among those who are most vulnerable’ is made without evidence, nor does the statement explain how this loss of life might come about, or how it might be avoided by ‘vaccination’.

The result is a statement that might have been drafted by PR consultant working for Pfizer or Moderna, both of whose ‘vaccines’ have been developed using tainted cell lines in confirmatory lab testing. The Oxford-AstraZeneca vaccine also uses a human-derived cell strain (called HEK 293) to develop its Covid-19 ‘vaccine’, although the tainted cells are filtered out of the final ‘vaccine’ product. Another statement of the Irish bishops that ‘many of the vaccines currently being developed do not depend for their design or production on foetal cell lines’ was patently disingenuous.

# All claims about ‘viruses’ as pathogens are false

**MY thesis is not complex: all claims about viruses as pathogens are false and based on easily recognised, understandable, and verifiably false interpretations.**

The true causes of the diseases and phenomena attributed to viruses have a different explanation, and one that is much clearer than the current prevalent pseudo-explanations.

This is because, while scientists in laboratories think they are working with viruses, in fact they are only working with certain components of dying tissues or cells acquired under very special circumstances. Their basic belief is that these tissues and cells die because they are infected with a virus.

In reality, these laboratory tissues and cells die because they are starved and poisoned as a result of the methodology of testing itself.

Virologists mainly believe in the existence of viruses because they administer to the tissues and cells supposedly ‘infected’ blood, saliva, or other presumably ‘infected’ body fluids, and this, it must be emphasised, is on top of the cessation of nutrient solution and after the initiation of poisoning by toxic antibiotics.

The great insight, however, is that the tissue and those cells would also die, and do so completely on their own – even without the addition of the supposedly ‘infected’ materials.

Virologists don’t get this! By the most basic scientific standards, they should have at least conducted control tests to be sure that it was really ‘viruses’ that led to cell and tissue death. In order to effectively establish the alleged ‘multiplication’ of viruses in cells, they should have conducted additional tests in a control group administering sterile substances from core healthy people. This would be to check that it was not the method itself that produced or falsified the results.

These control experiments have never been carried out to date.

In the light of the measles-virus process, I did have these control experiments performed, and in an independent lab, with the result that the tissue and the cells indeed die by themselves just as well as if they had come into contact with so-called ‘infected’ material.

This seems to me to be an important finding, but on the other hand it is also trivial since it is precisely the task of control experiments to rule out the possibility that the method or technique used is not responsible for the result rather than the reality itself.

Control experiments are thus of the highest priority and are even a basic condition for a result to be considered ‘scientific’. As we shall see, the court-appointed expert on the measles virus trial – Dr Podbielski, see further in this article – found that some basic publications of fundamental importance to virology as a whole (notably John Franklin Enders’ June 1954 paper, and six more articles thereafter), contained no control experiments.

From this we can draw the conclusion that since then, and without really realising it, scientists have been acting extremely unscientifically. The explanation for this action, which is incompatible with scientific reasoning, is historical: in June 1954 an unscientific and contradictory hypothesis was published, concluding from the death of tissue in a test tube the presence of a virus.

Six months later, on December 10, 1954, the first author of this hypothesis received the Nobel Prize in medicine. This turned a speculative hypothesis into virtually ‘scientific fact’ in the eyes of many, and one that is not questioned to this day. Since then, the death of tissues and cells in a test tube is consistently but erroneously viewed as evidence of the existence of viruses.

So it is really quite simple: the death of tissues and cells is mistakenly considered to be the isolation of a virus. Thus, whatever else one may claim, the fact remains that a virus was never isolated in the true sense of the word – that is: shown as a whole or characterised biochemically.

The electron microscopic photographs of alleged viruses, for example, in reality show just regular particles of dying tissues and cells, usually at most in model form. However, since those involved BELIEVE that these dying tissues and cells are viruses, this dying of cells and tissues in the form of all kinds of cellular parts is also called the “multiplication” of viruses.

The parties involved believe this to this day, and, to repeat, especially

because the inventor of this method, by winning the Nobel Prize, is still considered an authority. Questioning that authority is not even considered.

It is important to note that this same mixture, which is thus made up of dying tissues and cells from monkeys, fetuses from cattle and toxic antibiotics, is no different in any way from what is called a ‘living vaccine’. It is used without purging it of everything non-virus (of everything that is, since viruses do not exist) as a supposedly healing injection, on the assumption that it would consist of ‘attenuated’ viruses. However, it consists mainly of foreign proteins, nucleic acids (DNA/RNA), cytotoxic antibiotics, microbes and spores of all kinds.

Thus, a vaccine is nothing more than a mixture of cellular waste and bacteria. In other words, components that a normal body would immediately excrete. This mixture is therefore toxic. It is what the body secretes as waste. It is mainly injected into the muscles of children during the vaccination process, in an amount that, if injected into the vein, would certainly lead to immediate death.

Only with total ignorance and blind faith in the state authorities who ‘test’ and approve vaccines can this be described as ‘a little harmless prick’. These verifiable facts demonstrate the danger and negligence of the scientists and politicians who claim that vaccines are safe, have little to no side effects, and protect against disease.

None of this is true and provable; on the contrary, if you look at it scientifically, you will find no benefits of vaccines, and

there is simply no evidence for the claim that they protect you.

It should be emphasised that an actual, completely described virus does not exist in the entire ‘scientific’ literature. This is because the process of arriving at such a description is by consensus, with the parties involved traditionally arguing over what does and does not belong to the virus. This has taken decades with the measles virus, for example.

In the case of the so-called new Chinese Coronavirus 2019 (now renamed 2019-nCoV), this consensus process strangely took only a few mouse clicks. However, this is not surprising when you know that constituents are indeed extracted from dead tissues that then end up in a database. It is these components, which can come from many different organisms, that are finally assembled into an artificial virus model.

The process is as follows: from a database containing the molecular structures of nucleic acid components – again, it should be emphasised that these already come from dead tissues and cells that have themselves been biochemically manipulated – a number of these are selected and used to construct a much longer, so-called ‘complete’ DNA strand of a new virus.

Much can be said about this ‘technique’, but the basic insight is that these manipulations, called ‘alignments’, simply do not correspond to any ‘complete’ or known genetic material of a virus. Yet this is then referred to in the literature as its ‘genome’.

For the sake of convenience they ignore the fact that during

the construction of a ‘viral DNA strand’ – I mean this completely conceptually, in fact nothing is ‘constructed’ – certain sequences that are considered ‘unsuitable’ are smoothed out and missing sequences (at least missing from the conceptual model that one maintains) are added.

Thus, in this way, a genetic DNA sequence is invented. It has never been discovered as a whole and therefore didn’t exist until it was created by man. These ‘smoothings’ and additions form, with short pieces that do fit the conceptual model, a larger whole that is then called ‘a viral DNA strand’. Again, in reality this does not exist; it only exists in the minds of the ‘scientists’.

An example: If you study the conceptual composition of the DNA strand of the measles ‘virus’ and compare it to the actually available short fragments of the cells’ own molecules, more than half of the molecule particles that should make up this virus are missing. Some of these were even artificially added biochemically while the rest are just... made up.

I am not inventing this. This is reality, but because no one even dares to suspect that they are working so amateurishly, no one thinks to check this out properly, and so the illusion persists.

The Chinese scientists, who thus claim that the majority of the nucleic acids, from which the genome of the new China Corona Virus 2019 has been ‘sequenced’, are largely derived from the DNA of venomous snakes, are, like all of us, victims of a by now global misdirection. The more ‘viral’ DNA strands are invented in the way previously described, the more similar a new ‘virus’ is to everything that has been ‘established’ before.

That’s right. So there is ironically method in error. But just because you come up with a theory, within which everything is consistent, doesn’t mean that theory is true. All you are doing is fooling yourself; you may be moving yourself comfortably within this theory – you even call it science and claim that it represents reality – but really the impression of consistency springs only from the congruence of your thinking with that of your predecessors. At the root, illusion continues to reign, and it springs from an invalid experiment.

UK media's covid reporting failings exposed

Former editor also condemns 'deeply disturbing' censorship and silence

**A GROUP of alarmed and frustrated UK journalists have pointed to disturbing and colossal failings of their own industry to reveal the true facts about the covid 'pandemic'.**

They say the past 18 months have seen constant censorship by media bosses and colleagues, denying the public the real story.

The group, called 'Holding the Line, Journalists Against Covid Censorship', claimed that since March 2020 the UK media has:

- frequently published fear-inducing and sometimes inaccurate news coverage;
- undermined initiatives such as the Great Barrington Declaration that offer alternatives to the Government's covid-19 mitigation

policies, while hit pieces have been commissioned targetting scientists who dissent from the dominant covid-19 narrative;

- helped foster what is now emerging as a hostile environment for people who choose not to have a covid-19 vaccine.

The group, involving a couple of dozen people in Great Britain and Ireland, is made up of journalists from multiple sectors including press, broadcast, freelance and PR.

Significantly, they say they are concerned that much of the UK media is turning a blind eye to covid-19 data and analysis that challenges the Government narrative.

It also alleges that the UK Media has often failed to:

- provide proper context for statistics on covid-19 'cases' and deaths;
- give due coverage to the alternative treatments such as Ivermectin, Fluvoxamine, Hydroxychloroquine and EXO-CD24;
- enquire into the methodology of the PCR process, particularly its suitability as a diagnostic test, and the cycle thresholds at which they are run;
- provide a balanced account of the cost and impact of the lockdown policy;
- give serious attention to (when not downplaying) instances of adverse reactions to the covid-19 vaccination, including death (few media platforms reference data from the Government's Yellow

Card vaccine injury reporting scheme, for example);

- report on and condemn the routine censorship by tech giants of dissenting voices and opinions;
- 'follow the money' by subjecting the interconnected political, financial, philanthropic and industrial interests responsible for the covid-19 programme to sustained and proper scrutiny.

The forum, highlighted on UK Column News on July 7, is reportedly 'building a head of steam'.

At that point it had not established a website but had got its first statements out, berating the British media for what it has done in the past 17 months.

Graham Crawford, a former award-winning Scottish weekly newspaper editor, told The Light: "I'm not a member of this group but its formation and statements are long overdue.

"I'm trying not to be angry and instead be grateful they are finally speaking out, but I can't help but ask – what the hell have these people been doing this past year?

"Where have they been? And what on earth is going on with the rest of this once honourable industry? How do they sleep at night – or are they just totally stupid and question nothing?

"And do they really think it is reasonable to terrorise a population daily for 17 months? Do they not know they are causing

## Gates & Soros invest \$40 million in covid testing

**A CONSORTIUM of investors led by the Soros Economic Development Fund (SEDF) and the Bill & Melinda Gates Foundation are buying UK-based covid testing company Mologic, which has developed a 10-minute coronavirus test and is best known for its deep-nostril swab test for the disease.**

According to Forbes, citing a Monday press release, the buyout was done to increase access to "affordable state-of-the-art medical technology" via a rapid 'lateral flow' test, which offers an early-warning screening for covid-19, as negative tests are going to be increasingly required to go back to 'normal life' - along with one's vaccine passport of course.

The Gates-Soros collaboration is part of a new initiative, Global Access Health (GAH), which will invest "at least" \$41 million in the deal, according to the statement. The transaction will feature a buyout of all Mologic's existing shares - including investments held by Foresight Group LLP and Calculus Capital.

This isn't the first time Gates and Soros have collaborated. In 2015, a Jeffrey Epstein funded think tank, the International Peace Institute, hosted a "Preparing for Pandemics" conference in Geneva - with senior officials from the Gates Foundation, Open Society, WHO, CDC, Red Cross and Pasteur Institute in attendance.

There's only one reason Mr

Gates would bother to put money into this company, and that is to return a vast profit. The only way he will do that is through the continuation of the covid-19 fraud that has infected the lives of people across the world for the past seventeen months.

Mologic is a UK-based lateral flow test developer which has created 10-minute covid tests. Gates and Soros hope that the tests will cost as little as \$1 to produce.

Soros and Gates are part of the billionaire community looking to direct their philanthropic efforts to the so-called global south, referring broadly to the regions of Latin America, Asia, Africa and Oceania that many fear will be left behind as the more affluent West accelerates its program of vaccinations, testing and 'biosecure bubbles' in the years ahead. Sean Hinton, the CEO of the Soros fund, said in a statement that the pandemic has "painfully demonstrated the fundamental inequities" in global public health, adding that this "unique transaction" has brought philanthropic funds and investors together to address the issue.

Roxana Bonnell, a public health expert from Soros' Open Society Foundations, which claims to be the world's largest private funder of human rights and social justice advocacy groups, said: "As we have seen during the covid-19 pandemic, access to testing is absolutely essential when it comes to containing the spread of contagious disease—an issue that ultimately affects us all".

enormous psychological harm?

"The failings of the UK media in its covid reporting have been screaming out at us since last spring.

"Today's journalists do not investigate. They merely regurgitate state propaganda. They are shameless.

"It has torn me apart to witness what has gone on.

"I find it deeply worrying and disturbing. The media was always the last sanctuary and saviour of truth-tellers and whistleblowers, and

never has that been needed more.

"But where do the good people go now to hope to right a wrong? Certainly not the BBC, ITV or Channel 4. Certainly not any of the mainstream press.

## Covid-19... the final nail in the coffin

**SEVERAL** years ago, I wrote a book called **Doctoring Data** to help people navigate their way through medical headlines and data.

I wrote it because I was deeply concerned that medical science had been taken over by commercial interests. Much of the (research) data was enormously biased, thus corrupted, and I wanted to show how bias gets built in.

I was not alone in my concerns. John Ioannidis wrote the very highly cited paper 'Why most Published Research Findings are False' back in 2005. It has been read by many thousands of researchers, so they can't say they don't know.

Marcia Angell, who edited the New England Journal of Medicine for twenty years, wrote:

"It is simply no longer possible to believe much of the clinical research that is published, or to rely on the judgement of 'trusted' physicians or 'authoritative' medical guidelines. I take no pleasure in this conclusion, which I reached slowly and reluctantly over my two decades as an editor of the NEJM."

From Peter Gotzsche's book, 'Deadly Medicine and Organised Crime':

"The main reason we take so many drugs is that drug companies

don't sell drugs, they sell lies about drugs... virtually everything we know about drugs is what the companies have chosen to tell us and our doctors... if you don't believe the system is out of control, please e-mail me and explain why drugs are the third leading cause of death."

Richard Smith, former editor of the British Medical Journal:

"Twenty years ago, the statistician Doug Altman published an editorial in the BMJ arguing that much medical research was of poor quality and misleading. He wrote that it was seriously flawed through inappropriate designs, unrepresentative/small sample, incorrect methods of analysis and interpretation... Twenty years later, I feel that things are not better, but worse..."

In 2002 I wrote a book on medical journals. My confidence that 'things can only get better' largely drained away.

Medical research has inexorably turned into a very lucrative industry. Medical journals charge authors thousands of dollars to publish their research.

It is all very profitable for big publishing houses. The Return on Investment (profit) is around 35%. Pharmaceutical companies can afford the publication fees but it is very difficult for any researcher not supported by a university or pharmaceutical company to publish anything unless they are independently wealthy.

Driven by financial imperative, the research has inevitably become biased. He who pays the paper, calls the tune.

A naïve researcher published a scientific article in a respectable journal. She thought her article was straightforward and defensible. It used only publicly available data and her findings were consistent with much of the literature on the

topic. Her co-authors included two distinguished statisticians.

To her surprise her publication was met with unusual attacks from unexpected sources within the research community. These attacks were not pursued through normal channels of scientific discussion. Her research became the target of an aggressive campaign of insults, errors, misinformation, social media posts, gossip and complaints to her employer.

The goal appeared to be to undermine and discredit her work. The controversy was deliberately manufactured and the attacks primarily consisted of repeated assertions of preconceived opinions. She learned first-hand the antagonism that could be provoked by inconvenient scientific findings.

Development of public health policy and clinical recommendations is complex and needs to be evidence-based rather than belief-based. Guidelines and recommendations should be based on objective and unbiased data.

Where is science in all this?

I don't mind attacks on ideas. I like robust debate. Science can only progress through a process of new hypotheses being proposed, attacked, refined and strengthened – or obliterated. But what we see now is the obliteration of science itself.

Anyone who has been a scientist for more than 20 years will realise that there has been a progressive decline in the honesty of communications between scientists and their institutions and the outside world.

Science must be an area where truth is the rule or else the activity stops being scientific and becomes something else: Zombie science, a science that is dead but artificially sustained by a continual infusion of funding. From a distance, Zombie science looks like the real thing but it is not interested in the pursuit of truth - it is externally controlled and everything inside it is rotten.

"Scientists push the envelope of exaggeration, selectivity and distortion as far as possible and tolerance for this kind of untruthfulness has greatly increased over recent years. It is routine for scientists to 'hype' their status and 'spin' the importance of their research." - Bruce Charlton, Professor of Theoretical Medicine.

When covid-19 came along, the distortion and hype became so outrageous that I almost gave up trying to establish what was true, and what was just made up nonsense.

I stated right at the start that vitamin D could be important in protecting against the disease and recommended vitamin C for those

already in hospital. I was attacked by fact checkers, along with anyone else promoting vitamins to reduce the risk of covid-19 infection. Vitamin C is known to have powerful healing activity. It has been known for years.

As of today, any criticism of the mainstream narrative is simply being removed. Those who dare to raise their heads above the parapet have them chopped off.

Where does the censorship and punishment end? Well, we know where it ends.

We are heading for some form of totalitarian state, where dissent against the medical 'experts' will be punishable by imprisonment. We are already in a situation where doctors who fail to follow 'guidelines' can be sued or struck off.

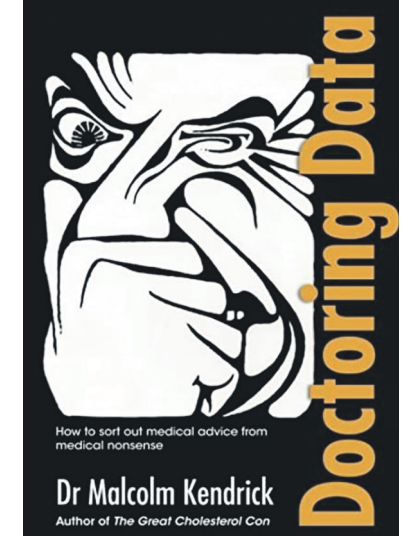

# The ‘Nazification’ of the NHS

**THE coordinated command-and-control over society called Gleichschaltung was the deadly regime of subjugation in 1930s German totalitarianism, later known as ‘Nazification’.**

This medical apartheid operates whenever patients attend a healthcare facility or call in via their GP, 999, 111 etc. They are processed through a skewed and biased system which separates patients based on ‘respiratory’ or ‘non-respiratory’ symptoms. This is not the usual medical triage: it is a new, abnormal, skewed, biased and bastardised version.

Any patients identified as ‘respiratory’ will attract a greater likelihood of receiving a presumptive ‘covid-19 diagnosis’ based on perceived symptoms/signs without any actual test results/physical evidence; or a confirmed ‘covid-19 diagnosis’ based on highly variable/interpretive tests. This skewed ‘covid-19-triage’ exposes

the unwitting patient to further potential for continuing misdiagnosis and unnecessary medical intervention(s).

Statistics are used to inflate the false perception of an out-of-control epidemic. This helps manufacture the ‘pseudo-epidemic’ using real patients as fodder to bump up the numbers and legitimise medical apartheid.

The accuracy of the medical tests used to diagnose the ‘novel coronavirus’ (‘SARS-Cov-2’) has never been scientifically proven. ‘SARS-CoV-2’ is only claimed to cause a ‘new’ disease, ‘covid-19’.

Both the minute blood clots and iron-haemoglobin dissociation reported in those dying with a ‘covid-19’ diagnosis are as likely due to electromagnetic radiation as they are to any alleged ‘novel coronavirus’.

So, we still do not have any live sample of an actual virus cleaned of human cellular debris. This was the first major reason why 22 international scientists in December 2020 co-authored a paper exposing this ‘test’ (see: <https://cormandrostereview.com/report/>).

In April 2020, the World Health Organisation (WHO) instructed all national health agencies that ‘virus isolation is not recommended as a routine diagnostic procedure’.

staff towards making ‘covid-19’ the ‘diagnosis-of-choice’. It is surely also wrong that everyone is now considered to be an asymptomatic

‘Typhoid Mary’, spreading a presumed disease, as shown by the infamous government fear campaign, ‘Anyone Can Have It. Anyone Can Transmit It’.

A government-created list of generic symptoms is fed via these hysterical campaigns to both public and health professionals alike. They include common non-fatal phenomena: sore throats, runny noses, coughs, feeling hot etc. This weaponises people’s everyday experiences, creating contagion fear and loathing, promoting widespread paranoia and more hysteria. These are nondescript symptoms repackaged officially as ‘covid-19 disease’.

These hysterical perceptions of ‘covid’ symptoms are further inflated by fear porn soundbites and phrases such as ‘killer virus’. They fuel the sinister mechanism driving health professionals to knowingly or unknowingly misdiagnose ‘covid-19’ in the absence of any accurate tests or physical findings. These misperceptions also coerce people into submitting to experimental injections which are causing incredible harm to subjects. Many will buckle, fearful of future illness and travel bans.

These biased, corrupted and bastardised processes are now enshrined in every day medical practice. They are perverting the normal ‘differential diagnosis’ and are bolstering and magnifying the official statistics of the covid pseudo-epidemic.

The true accuracy of any ‘covid test’ is scientifically unknown because no medical gold standard exists to underwrite their use (see: <https://www.bmj.com/content/369/bmj.m1808>). This means that the ‘covid PCR test’ is untrustworthy. Unwitting patients are deceived into receiving a dodgy diagnosis (+ or -). If ‘diagnosed’ positive, more and more unnecessary (and potentially dangerous) drugs are likely to be given.

Stopping face-to-face medical examinations to discourage physical touch via online consultations (‘telemedicine’) is another perversion of normal practice. Safe medical diagnosis

must involve physical examination using touch and non-isolation of patients unless a true high consequence infectious disease exists (which the government says ‘covid-19’ is not).

The implications of such misdiagnoses are serious and unremitting. Deaths and illnesses are fraudulently created in the absence of real disease. Illnesses are then induced by medically unwarranted administration of unnecessary drugs and actions (e.g. ventilation, injections etc.), a process called iatrogenesis. This is why the Hippocratic Oath implies that all doctors hold a double-edged sword over us – they can both kill and cure.

Covid Nazification dupes patients into receiving unwarranted drugs and treatments. In chronic and terminal illnesses, patients’ deaths are reportedly being hastened by over drugging on ‘end-of-life pathways’ using sedatives like Midazolam.

Instead of receiving oxygen via masks or nebulisers, acutely-ill patients are subjected to unwarranted and invasive oxygen-delivery tubes (‘intubation’), necessitating the continuous mechanical pumping of oxygen into their lungs (‘mechanical ventilation’).

These are some of the most hazardous treatments any patient can receive. When unwarranted, they can only injure people causing respiratory and kidney failure, and failure of major organ systems (‘multi-organ failure’). This ultimately hastens or actually causes death.

Routine Nazified practices within misnamed ‘care’ pathways now exist in the same untrustworthy health ‘care’ system for which people applauded and displayed rainbows.

# Letter to physicians: Four new scientific discoveries regarding the safety and efficacy of covid-19 vaccines

**DOCTORS For Covid Ethics has sent the following letter to tens of thousands of doctors in Europe, summarising four recent scientific findings critical to the covid-19 vaccination program.**

*Dear Colleague:*

Four recent scientific discoveries are herewith brought to your urgent attention. They alter the entire landscape of the covid-19 pandemic, and they force us to reassess the merits of vaccination against SARS-CoV-2.

## Summary

Rapid and efficient memory-type immune responses occur reliably in virtually all unvaccinated individuals who are exposed to SARS-CoV-2. The effectiveness of further boosting the immune response through vaccination is therefore highly doubtful. Vaccination may instead aggravate disease through antibody-dependent enhancement (ADE).

## Discovery 1:

### ***SARS-CoV-2 spike protein circulates shortly after vaccination***

SARS-CoV-2 proteins were measured in longitudinal plasma samples collected from 13 participants who received two doses of Moderna mRNA-1273 vaccine [1]. With 11 of the 13, the SARS-CoV-2 spike protein was detected in the blood within only one day after the first vaccine injection.

## Significance.

Spike protein molecules were produced within cells that are in contact with the bloodstream—mostly endothelial cells—and released into the circulation. This means that a) the immune system will attack those endothelial cells, and b) the circulating spike protein molecules will activate thrombocytes. Both effects will promote blood clotting. This explains the many clotting-related adverse events—stroke, heart attack, venous thrombosis—that are being reported after vaccination.

## Discovery 2:

### ***Rapid, memory-type antibody response after vaccination***

Several studies have demonstrated that circulating SARS-CoV-2-specific IgG and IgA antibodies became detectable within 1-2 weeks after application of mRNA vaccines [1–3].

## Significance.

Rapid production of IgG and IgA always indicates a secondary, memory-type response that is elicited

through re-stimulation of pre-existing immune cells. Primary immune responses to novel antigens take longer to evolve and initially produce IgM antibodies, which is then followed by the isotype switch to IgG and IgA.

A certain amount of IgM was indeed detected alongside IgG and IgA in some studies [1,4]. Importantly, however, IgG rose faster than IgM [4], which confirms that the early IgG response was indeed of the memory type. This memory response indicates pre-existing, cross-reactive immunity due to previous infection with ordinary respiratory human coronavirus strains. The delayed IgM response most likely represents a primary response to novel epitopes which are specific to SARS-CoV-2.

Memory-type responses have also been documented with respect to T-cell-mediated immunity [5–7]. Overall, these findings indicate that our immune system efficiently recognizes SARS-CoV-2 as “known” even on first contact. Severe cases of the disease thus cannot be ascribed to lacking immunity. Instead, severe cases might very well be caused or aggravated by pre-existing immunity through antibody-dependent enhancement (ADE, see below).

## Discovery 3:

### ***SARS-CoV-2 elicits robust adaptive immune responses regardless of disease severity***

Serum antibody profiles were reported for 203 individuals following SARS-CoV-2 infection [8]. 202 (>99%) of the participants exhibited SARS-CoV-2 specific antibodies. With 193 individuals (95%), these antibodies prevented SARS-CoV-2 infection in cell culture and also inhibited binding of the spike protein to the ACE2 receptor. Furthermore, CD8+ T-cell responses specific for SARS-CoV-2 were clear and quantifiable in 95 of 106 (90%) HLA-A2-positive individuals.

## Significance.

This study confirms the above assertion that the immune response to initial contact with SARS-CoV-2 is of the memory type. In addition, it shows that this reaction occurs with almost all individuals, and particularly also with those who experience no manifest clinical symptoms.

The goal of the vaccination is to stimulate production of antibodies to SARS-CoV-2, but we now know that such antibodies can and will be rapidly generated by everyone upon the slightest viral challenge, even without vaccination.

Severe lung infections always take many days to develop, which means that if the antibodies generated by the memory response are needed, they will arrive on time. Therefore, vaccination is unlikely to provide significant benefit with respect to the prevention of severe lung infection.

## Discovery 4:

### ***Rapid increase of spike protein antibodies after the second injection of mRNA vaccines***

IgG and IgA antibody titres were monitored before vaccination and after the first and the second injection of mRNA vaccines [3]. Antibody titres rose with some delay after the first injection, then plateaued, but rose again very shortly after the second injection.

## Significance.

Even though the antibody response to the first injection is of the memory type, the small time lag after the injection may mitigate adverse reactions, because the abundance of spike protein on the cells in the blood vessel walls and in other tissues may have already passed its peak when the antibodies arrive.

The situation changes dramatically with the second injection. Then the spikes are produced and protrude into the bloodstream that is already swarming with both reactive lymphocytes and antibodies. The antibodies will cause the complement system [9,10] and also neutrophil granulocytes to attack the spike protein-bearing cells. The possible consequences of all-out self-attack by the immune system are frightening.

### ***Antibody-dependent enhancement of disease***

As described, memory-type immune responses ensure the rapid rise of antibody titres after initial exposure to SARS-CoV-2, rendering the benefit of vaccine-induced antibody response

exceedingly doubtful. Regardless, we should not assume that high antibody titres against SARS-CoV-2 will always improve the clinical outcome. With several virus families—in particular with Dengue virus, but also with coronaviruses—antibodies can aggravate rather than mitigate disease. This occurs because certain cells of the immune system take up antibody-tagged microbes and destroy them. If a virus particle to which antibodies have bound is taken up by such a cell, but it then manages to evade destruction, it may instead start to multiply within the cell. Overall, the antibody will then have enhanced the replication of the virus. Clinically, this antibody-dependent enhancement (ADE) can cause a hyperinflammatory

response (a “cytokine storm”) that will amplify the damage to the lungs, liver and other organs of the body.

Attempts to develop vaccines to the original SARS virus, which is closely related to SARS-CoV-2, repeatedly failed due to ADE. The vaccines did induce antibodies, but when the vaccinated animals were subsequently infected with the virus, they became more ill than the unvaccinated controls (see e.g. [11]). The possibility of ADE was not adequately addressed in the clinical trials on any of the covid-19 vaccines. It is therefore prudent to avoid the danger of inducing ADE through vaccination and instead rely on proven forms of treatment [12] for dealing with clinically severe covid-19 disease.

The collective findings discussed above clearly show that the benefits of vaccination are highly doubtful. In contrast, the harm the vaccines do is very well substantiated, with more than 15,000 vaccination-associated deaths now documented in the EU drug adverse events database (EudraVigilance), and over 7,000 more deaths within the UK and the US [13].

# Why Big Tech is the enemy of freedom

**THERE has never been a better demonstration of Lord Acton's famous dictum 'Power tends to corrupt, and absolute power corrupts absolutely' than the rise to worldwide business dominance of the American Tech corporations (Facebook, Apple, Twitter, Microsoft, Amazon, Google) and their dangerous extension of that wealth into political power over democratic parties, governments and the whole of public discourse.**

So it came as no surprise that free speech platform Parler became a victim of Apple's political power and bias when it was taken down from Apple's App Store.

This was despite the fact that the App Store carries Twitter and Facebook, both of which have been used repeatedly by Antifa, Black Lives Matter, and other groups to coordinate acts of violence and lawlessness across the United States.

Rose City Antifa, a group which has repeatedly supported acts of violence and disorder in

Portland, Oregon, still has an active page on Facebook with more than 20,000 'likes'.

The Parler website itself was taken down altogether by Amazon, another multinational behemoth flexing its political muscle.

John Matze, Parler CEO, rightly pointed to Apple hypocrisy: "Anyone who buys an Apple phone is apparently a user. Apparently they believe Parler is responsible for all user-generated content on Parler. Therefore, by the same logic, Apple must be responsible for all actions taken by their phones. Standards not applied to Twitter, Facebook, or even Apple themselves, apply to Parler."

Apple's attack on Parler is clear. Matze said Amazon had assured them there was no problem. But then they seemed to worry Trump having been forced off Twitter, would go to Parler... so they took it down.

So the award for political hypocrite of the years goes to Amazon's Jeff Bezos, one of the richest men in the world.

Twitter removed President Trump from their platform but not of course the Bidens or Kamala Harris or Nancy Pelosi for encouraging far left violence last year. Equally Twitter apparently has no problems with its use by Iranian religious extremists or Chinese Communism.

Apple also told Parler that

material 'intended to incite violence or other lawless acts has never been acceptable on the App Store', but on the day Apple censored Parler 'Hang Mike Pence' trended on Twitter.

Twitter is clearly allowing its users to coordinate criminal acts on the platform, with dozens of tweets identifying looting targets in the USA still on the platform, despite the fact that the site was notified by concerned citizens.

During the US Senate enquiry into the power of U.S. Big Tech, Senator Ted Cruz asked the CEO of Twitter, Jack Dorsey: "Who the hell elected you?"

Who indeed? That is the point. These imperial corporate dictators are in no way constrained by voters or parliamentary scrutiny. They rule by self-appointment, using the collective investment savings of the country to lobby, get favourable tax treatment and buy their political power.

# Government primes businesses to enforce medical apartheid

# Communitarianism - how they usurp genuine localisation and independence

**AMERICANS have a lot more in common with the British than many may realise. On both sides of the Atlantic there is a very quiet and totally identical revolution underway. What binds them in a way that surpasses all others is the simple fact that neither side knows what exactly their enemy is called.**

"stakeholder" councils. A stakeholder is defined as a "group, person, organization or system", which can be just about anybody or anything. You'll find the term used in just about every government and grant funded project in existence today. It's always used as if it means you, but it doesn't.

Forming "partnerships" with "stakeholders" is an effective way to bypass voters and taxpayers living in the affected regions. Their community goals and missions always include "raising public awareness" and advising legitimate government bodies how to adopt the new communitarian laws (never identified as that though, unless it's a former communist new member EU state like Serbia, Croatia or the Czech Republic, or Bolivia and Peru with their new openly communitarian constitutions). Claiming to include more citizens in the democratic process, communitarian councils do just the opposite. And

they continually seek more power.

Bill's right - we are all communitarians now. What that means to us is any body's guess. Most people will adopt the vague party line and agree it's a fresh solution to partisan politics. The libertarians will tell you they like the part about giving power to unelected, self-appointed community councils who have the communitarian power to regulate everyone's personal life in the community. The Catholics will tell you they just hope a communitarian spirituality is included. The Protestants, Jews and Muslims won't want to seem selfish so they'll assume a moral value in it somewhere too. The left will dismiss it a right wing conspiracy theory and the far right will call it a communist plot.

Here's the part that our politicians and the "experts" never tell us about communitarianism: it's also the law of the European Union. Communitarian Law is the entire basis for the supremacy of law clause that overrules all national, state, county

and municipal laws in conflict with it.

Lots of really smart people will go to great lengths to explain the theory, how some parts of it make real sense to other smart people. Those same smart people will probably tell you they don't know anything about the law part, sorry. It's just a benign social theory, they say, one that rose and fell already, nothing to worry about. Others will tell you the law's a conspiracy theory.

Communitarian Law is the law regulating all community-based government. At the top level it represents the global community. At the middle level it represents the regional community. At the bottom it represent the local community ("not to be confused with local government." Amitai Etzioni).

In October, 2004, Professor Jan Mazak, Ph.D., Constitutional Court of the Slovak Republic published one of the most amazing descriptions of the EU I've ever come across. In it, he details the "immediate applicability of the communitarian law." He explains

that the Slovak Constitution gave the Slovak government the power to sign an international treaty that transferred some of the republic's power over to the EU Courts, telling in no uncertain terms that communitarian law overrules conflicting national laws.

There was one news report that identified the French and Dutch referenda rejecting the EU Constitution in 2005 as based on voter concerns about the EU's supremacy of communitarian law clause. But both times the Irish voted on it I couldn't find any Irish articles or debates about the EU communitarian legal system Ireland was adopting. I thought that a matter of such importance would become a primary issue in a national vote over joining the EU. It never even became a minor point. The theories of communitarian justice, economics, development, morality, policing and mandatory volunteerism are not up for debate. To join, or not to join, that is the only question.

But the real dilemma is this: communitarianism is also the philosophical/legal theory for 'global sustainable development'. Communitarian supremacy is the moral philosophy justifying new land and resource use regulations under UN Agenda 21. We don't need to accept EU style regional government to become communitarians. Yes the EU Communitarian system of harmonisation and norms is the model for all the emerging trade unions from the Middle East to Africa and South America. But we already adopted community government hook line and sinker when we changed our national mission statements to adopt sustainable development principles.

Americans, like their neighbors across the sea, are manipulated back and forth between the right and the left, and then they're admonished for not thinking more communitarian, whatever that means.

Communitarianism enriches experts, stakeholders and compliant citizens only. Individuals who can read and think for themselves need not apply. Voters who insist their national and state law reign supreme in their nations must be re-educated into more moral, 'enlightened' thinking. Our Common Destiny requires we all share one Common Purpose. We can forget Common Sense, it's completely outdated.

# The rule of lawlessness: C.H.I.S. Act 2021

**The Covert Human Intelligence Sources (Criminal Conduct) Act 2021, passed earlier this year, is a green light for crime to be committed by the regime. It allows the state to recruit others, including children, to commit crime as undercover CHIS.**

Powers have been given to numerous bodies including police forces, the intelligence agencies, the armed forces, the department of health and social care, the competition and markets authority, the environment agency, the financial conduct authority, the food standards agency and the gambling commission. Serious crimes like torture are not ruled out because members of parliament argued that a gang member might want a CHIS to prove himself by raping someone. They also came up with the flimsy excuse that the Human Rights Act would protect against abuse. So after being raped, murdered or tortured, the victim could decide to face the hell and costs of taking a public authority to court in a civil suit, with no actual possibility of punishment

for the offender or handler.

During the debate on amendments in the House of Lords Lord Paddick, a retired police officer and life peer, pointed out: "If ever there was evidence of a government simply giving its operational partners whatever they ask for, whatever the consequences, this Bill is it."

Existing investigatory powers under RIPA have been altered to legitimise the current regime's widespread disregard for the laws and customs of the land Wording is deliberately vague:

"A criminal conduct authorisation is an authorisation for criminal conduct in the course of, or otherwise in connection with, the conduct of a CHIS".

We are supposed to feel fine about this because the officer must believe that the criminal conduct is necessary for national security, for preventing or detecting crime or disorder, or is in the economic interests of the UK. The belief must be 'reasonable'. But what is reasonable to the current regime is idiocy to most. Their idea of a proportional response is shutting down society in case someone gets a sniffle.

This legislation allows for a child or vulnerable adult to wind up not only as a perpetrator, but also as a victim of crime. As Baroness Jones of Moulsecoomb has pointed out:

"This is child abuse by the government, using children as spies, it is obvious this government does not care about the rule of law... it protects its own while throwing others to the dogs".

The excuse for using children and vulnerable adults to commit crimes is that if they don't, criminal gangs will abuse them more. That children will only be used in 'exceptional circumstances' where no harm can be reasonably foreseen and that all this is in the best interests of the

child. Harm is defined as physical injury or psychological distress, but psychological damage is not specified. This leaves the possibility of trauma for the child which might only become apparent later.

Lord Bishop of Durham has pointed out: "How can using a child as a CHIS, and in doing so placing them at greater risk of harm, ever be in their best interest? Allowing these children to act illegally only worsens this".

16 and 17 year olds do not even have a right to have an appropriate adult present at meetings. And if a Judicial Commissioner rules that the criminal conduct authorisation is against the law, an officer can ignore this decision and keep the operation going. There is no protection for vulnerable adults that the state wants to use and abuse. The only requirement is to identify and evaluate the possibility of harm to the individual and then do nothing about it, other than making sure they understand the risks. There is nothing to stop a vulnerable person having to take part in terrorist activities or become a suicide bomber. Anyone who is injured or harmed, including the vulnerable

adult himself or herself, has no route to redress because the Act prevents access to the Criminal Injuries Compensation Act 1995 and the Criminal Injuries (NI) order 2002 from taking effect for authorisations involving this group.

There is no excuse for making children or vulnerable people into criminals, or using them as undercover operatives at all. This unconstitutional legislation gives carte blanche for crimes to be committed against anyone the regime dislikes, for example protesters or even their children and family members. As with the Coronavirus Act, here we have more written powers that are unlawful. The Tory party did not include their intention to legalise abuse of children and vulnerable people in its manifesto. Nobody voted for that.

## NHS Nurse: No regrets in standing up and speaking out

**I'm Kirsty, an ex-NHS staff nurse. I trained as an RGN in 2008. I have worked and specialised in medicine for the elderly and acute medicine. I started off my career in surgical. I have worked for the NHS nurse bank and with an agency.**

I was a charge nurse at the start of the pandemic and questioned protocols and actions of management regarding the safety of patients and staff. I'm a mother of three children and my priority was to keep myself safe so I can be here for them. Initially I was scared due to the mainstream media coverage of the situation, particularly working with elderly patients.

From early 2020, it was obvious to me that the figures were being over exaggerated by the media and politicians as we were not witnessing the overwhelming of local hospitals that was being portrayed. I think most people are now aware that what they were told would happen was a worst-case scenario and designed to make us fearful 'to protect the NHS'.

This year my biggest concern became the injuries I began to witness with the rollout of the vaccines in December. The public may not be aware that as nurses we are not trained in mRNA therapy. There was no training on any of the injections or the range of adverse effects we might expect to see. When I started to voice my concerns to colleagues about what I was witnessing, especially with the rise in the number of patients arriving at hospital with symptoms that could not easily be explained, I was made to feel very uncomfortable, and it soon became clear that this was an environment where those who were questioning the narrative were not welcome, despite what was happening right in front of our eyes.

I understand the real fear that any health professional has of speaking out about any concerns they have and the toll it has emotionally, professionally and socially. It is not easy to speak up.

On March 27th 2021 I finished

my last shift, as I could not see myself working for the NHS any longer.

I was so devastated and upset. That evening I made a video which I posted to social media because I wanted the public to know the risks of the vaccines. I also felt it important to make people, including fellow health professionals, aware of the government's Yellow Card Scheme, as it was evident many did not know what this was. It is my core belief that informed consent is vital to everyone who considers taking this trial gene therapy, and that they are made aware that they are taking part in a clinical trial which doesn't end until 2023.

I have so many nurses and other health care professionals contacting me, telling me the fears they have too - they do not want to work any more in these conditions but feel trapped. We all thought we had a secure job and a career for life.

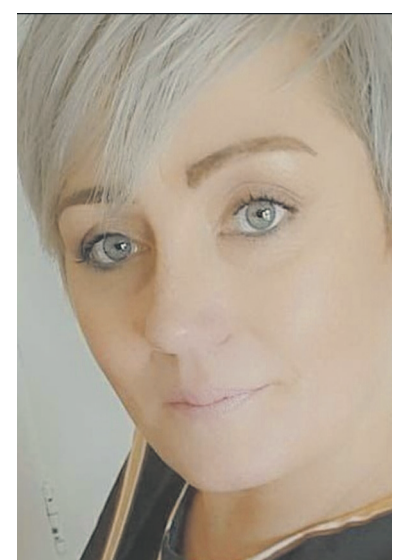
These times are unprecedented, and we were unprepared for what has unfolded. Since March I have been involved in helping agencies support others who are scared for

their future. I want to let others know that there IS another way. It is so important that we take control of our own path and change our mindset to be able to continue with our passion for helping others.

I am now branching out into other exciting opportunities that have come my way and have put in place some long-term financial security so that I never have to be worried about supporting my family. I have started retraining with alternative therapies and my crowdfunding campaign has paid for three other nurses to train too.

I have met so many wonderful people on my journey and I am so humbled by the offers of support, being part of a community who are taking control of their own lives and stepping outside the box to do so - there are more ways to be a nurse or doctor than in the NHS! It is simply amazing and refreshing to find people who think like me, and want to help people first.

I have no regrets in standing up and prioritising my patients and speaking out when things are wrong,



our code of conduct demands this, as does our own internal conscience.

# Movement growing in Scotland

‘Ordinary people scared for democracy.’

**THAT is the way in which ‘State of Fear’ Author Laura Dodsworth described those in attendance at the burgeoning political rallies in London in response to what is often lazily called ‘The Covid Crisis’ by the corporate-controlled media and politicians. She was responding to TalkRadio presenter Julia Hartley-Brewer’s assertion that she would be attending a demonstration in London on 26/06/21 for the first time - despite her own misgivings about walking alongside the likes of the ‘anti-vaxxers’. With upper estimates of attendance on the day in the millions, it seems many others had similarly decided that enough was enough after the announced delay to the ‘easing’ of lockdown restrictions on 14th June.**

North of the border, close to 1000 gathered for a demonstration at BBC Scotland HQ in Glasgow, in opposition to the proposed rollout of mRNA injections to young children. They marched from the rally point at Glasgow Green, through Argyle Street & the Broomielaw to Pacific Quay, where BBC headquarters are based. Attendees handed out handmade ‘yellow cards’ with contact details and total reported adverse reactions to covid-19 vaccinations to members of the public along the way. It was by all accounts the largest and most successful such event in Scotland to date, following a heavily-policed march through Glasgow’s Southside in April, which attracted the condemnation of First Minister Nicola Sturgeon on Twitter:

“The juxtaposition of this and the catastrophe unfolding in India is quite upsetting. Covid is not a hoax - as more than 10,000 grieving families in Scotland know, it is very real. Thankfully, things are getting better here & restrictions are easing - but we must still take care.”

The reasoning was that with just a little more restraint Scotland could ‘ease’ into freedom with the first step of the ‘roadmap’ out of lockdown due to begin in May. Freedom held hostage - constrained, conditional and converse to its true nature. It is a concept that the SNP government are unused to and, as been demonstrated

during the course of the pandemic, something they are highly skilled at using to their own advantage. Just look at the continued popularity of the party at the polls, winning 64 Parliamentary seats and falling just one seat short of a majority at the most recent Scottish Parliamentary election. This is despite stories such as SNP mis-spending coronavirus relief funds on manifesto promises, and the introduction of the ‘Hate Crime Act’ just before this year’s election - one of the most authoritarian pieces of legislation in Scottish history that will doubtless leave a dark mark over political discourse in the years to come.

Indeed the freedom movement in Scotland has struggled to distinguish itself in the Scottish political milieu that almost forces any new political movement to take a position on the constitutional question. By nature opposed to the SNP government and its covid-19 policies - seemingly competing with the devolved administration in Wales for the harshest and most arbitrary of all the UK devolved and central administrations - it has been an easier fit for those already opposed to the SNP politically. Support for independence in Scotland has been so successfully meshed with support for the dominant political party that it is hard to appeal for any movement outwith the deliberately narrowly-defined political discourse.

First-hand experience at such demonstrations in Scotland will show a much more colourful crowd than the ‘anti-vax’, ‘covid-denier’ bogeyman conjured by media and politicians. Much like Ms Dodsworth’s account of the people in the crowd at London’s events, those in attendance at rallies in Scotland are a diverse mix of young and old, professionals, students, people with disabilities, mums, dads, grandmothers: opposed to covid-19 restrictions and the needless rollout of experimental genetic therapy treatment to children. A prospect that Sturgeon said her “heart sang at the thought

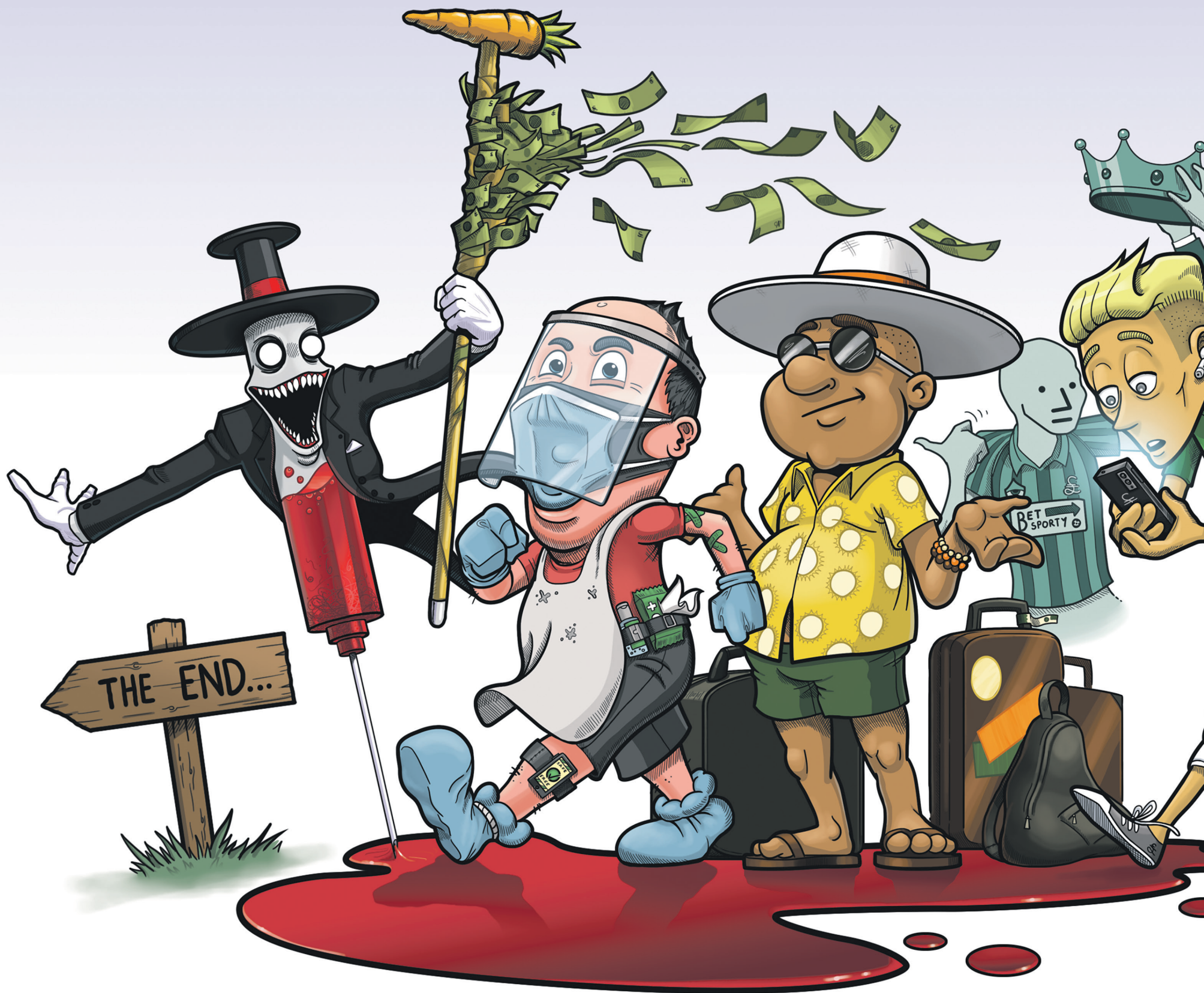
of”. And all at the hollow promise of freedom down the line: Scotland all-too-easily forgets that the ‘roadmap’ to it is the second in as many years.

Most cunningly, those campaigning for liberty, truth and transparency in the wake of covid in Scotland, as well as those who have decided to stop complying, now find themselves portrayed as the cause of continued restrictions and by extension, the reason for delaying another independence referendum. The SNP’s 2021 election manifesto promises an independence referendum: “after the covid crisis is

over”. (SNP 2021 Manifesto, P.5)

Despite all this, Scotland seems to finally be waking up from its SNP-induced slumber. On 26th, the Scottish Lion roared for the first time in a long while as people have started to realise that winning back individual sovereignty and liberty must come before more lofty propositions, lest they lose the ability to influence such matters altogether. And just as in the case of the covid regulations, people in Scotland are beginning to see that this needn’t be as narrowly or arbitrarily defined as it has been until now.

# California pays price of green energy push

**SIX months after a historic failure in the Texas power grid which collapsed when various ‘renewable’ sources of electricity failed simultaneously and dragged down the entire network, California has made an urgent request for extra power supplies to avoid blackouts this summer.**

It is an extraordinary step after suffering from rolling outages less than a year ago.

State energy officials asked the California Independent System Operator, which runs most of the grid, to contract for additional power capacity for July and August over concerns it will not be able to meet demand during the evening when solar production fades.

Of course, there was a convenient scapegoat on which to blame the collective lack of competence: global warming.

‘California is using all available

tools to increase electricity reliability this summer,’ the heads of the California Energy Commission, California Public Utilities Commission, and grid operator said, citing ‘unprecedented climate change-driven heat events, which are occurring throughout the West in combination with drought conditions that reduce hydroelectric capacity’.

Right, it’s always someone else’s fault that you could not properly budget even a few months in advance after keeping millions of people in the dark last year when California again blamed ‘global warming’.

However, if you know there is global warming and you suffer one nightmare summer in the dark because of it, can’t you extrapolate at least a year into the future?

Apparently not.

Their statement underscores California’s challenges as it begins summer already parched by drought that’s leaving hydroelectric reservoirs at historic lows. The state narrowly avoided rolling power outages

recently as extreme heat came early; and with few new generation sources on the horizon, supplies tighten when hot weather hits.

The state has taken a number of steps including adding battery storage (a complete disaster last summer) to prevent blackouts such as those last August, when demand overwhelmed the grid. However, it appears that may not be enough.

Procuring additional capacity ‘is taken out of an abundance of caution to ensure electric reliability and preserve the public health and safety of all Californians,’ the officials said.

They also cited delayed availability for some thermal power plants and said some resources expected to be running during the hottest months have now been delayed. Meeting demand is likely to be even harder this year with long-range forecasts suggesting above-average temperatures through September.

What is remarkable is that even Bloomberg, which has been on a crusade to crush non-green sources of power, admits that California’s problem is the state’s aggressive

push to cut carbon emissions by shifting to renewable energy.

Many gas-burning plants have closed, which means electricity supplies tighten at sunset as the production from solar generation fades. What’s more, big batteries being built to store solar power during the day and resupply the grid in the evening won’t be available in time for the state’s hottest months.

Is it time to admit that California’s green push has been a complete disaster and could lead to countless deaths during hot, sweaty days?

Of course, since we are talking about a socialist paradise this will never happen, and instead locals have even more brilliant ideas such as paying people *not* to use electricity.

“The short-term strategy needs to be centred around incentivising demand reductions instead of increasing supply,” said Abe Stanway, of Amperon Holdings Inc., which provides analysis to utilities and power traders. “The best way is to simply pay consumers more to use less during peak events.”

While electricity may not grow on trees in California, at least money still does.

## Iranian water riots turn fatal

**WATER and power shortage protests in Iran have now been raging continuously for weeks, resulting in multiple deaths and injuries particularly out of the restive southwest oil-rich province of Khuzestan, including the death of a police officer.**

State media by mid-July reported a death toll of three: ‘According to the state-run IRNA news agency, gunfire killed the officer in the city of Mahshar and another suffered a gunshot wound to his leg,’ the AP reported citing state sources.

Tehran has presented the violence and killings as the fault of “rioters” while the State Department early in the week referenced reports of security forces indiscriminately opening fire on peaceful protesters.

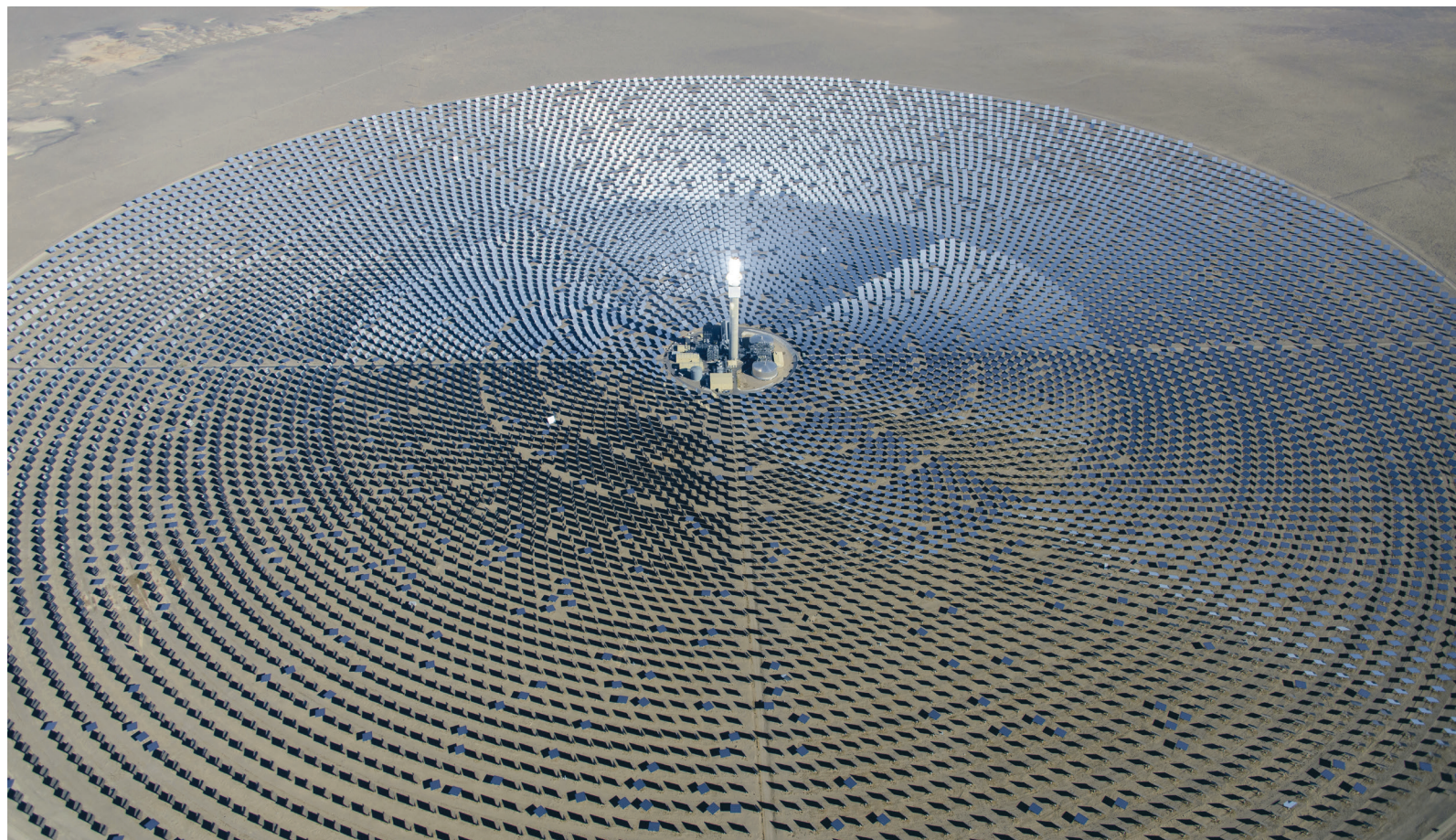
“We support the rights of Iranians to peacefully assemble and express themselves... without fear of violence, without fear of arbitrary detention by security forces,” U.S. State Dept. spokesman Ned Price said.

Chants saying “down with the Ayatollah” have also been reported based on widely circulating social media videos, also with external Iranian opposition groups as well as Saudi-funded think tanks in the West attempting to seize on the protests as an opportunity to weaken and overthrow the Islamic Republic regime.

Behind the crisis are US-led sanctions, severe government mismanagement of resources, but crucially what’s being dubbed the worst drought in 50 years.

One opposition group called Human Rights Activists in Iran was cited in AP as saying:

“As nearly 5 million Iranians in Khuzestan are lacking access to clean drinking water, Iran is failing to respect, protect, and fulfill the right to water, which is inextricably linked to the right to the highest attainable standard of health”.

# Another side of Gaddafi's Libya

**IT was a prosperous country, but the nation's wealth did not filter down to the Libyans - only Gaddafi's inner circle and cronies.**

Democratic? No, if you went against him you risked your livelihood and possibly your life.

It's well documented about the country's hit squads and also those sent abroad to hunt down the dictator's opposition. Where was free speech and debate?

Pre-Gaddafi, Libya was a clean and ordered country; under him it became broken with broken people.

In 2009, Gaddafi, an advocate of the United States of Africa, was appointed to lead the African Union for a year despite some member states' unease about his nomination. When his year's term ended he wanted to continue for another year, proclaiming he wanted to clean up the states' corruption.

However, his own country was full of corruption, nepotism and regime-sanctioned murders in Libya and across the world.

Many inaccurate statements circulated at the start of his demise and have continued to this day.

Fifteen misconceptions of Libya and Gaddafi have been written by Nizar Mhani of the Free Generation Movement and authenticated by a Libyan citizen.

**1. There are no electricity bills; it is free for all.**

Despite poor electricity infrastructure and poor coverage of electricity lines, even in the capital Tripoli, home owners pay monthly/quarterly electricity bills based on meter readings. Electricity is cut off over unpaid bills and reconnection upon payment is not instant. Some areas of Libya do not have electricity available at all.

**2. There is no interest on loans, banks are state-owned and loans given to all its citizens at 0% interest by law.**

Banks have been giving out loans for many years. There is a percentage rate charge on all loans, but in the spirit of 'Islamic ethics' it is not called 'interest', it is called an 'administrative expense'.

**3. A house is considered a human right in Libya - Gaddafi vowed that his parents would not get a house until everyone in Libya had a home.**

Gaddafi's father has died while his wife and his mother are still living in a tent.

Gaddafi abused this human right. Political opponents and successful

businessmen/women had their homes confiscated and handed over to regime members. Many farms, homes and businesses were confiscated during three infamous phases.

In 1969, the dreaded Green Revolution saw free officers rewarded land, homes, and farms that sometimes belonged to others who were not compensated.

In the late 70s, 'The Home Belongs to its Dwellers' law was passed overnight and thousands of homeowners instantly lost their homes as tenants claimed ownership. The law also applied to farms and shops.

In the 90s, the 'Purification Committees' were run by the slogan 'From where did you obtain this?', a form of ultra-socialism where people's possessions, including homes and businesses, were confiscated if seen to be 'surplus to requirement' or contributing to a 'monopoly'.

Meanwhile, Gaddafi lived in a sprawling 6km square compound in the centre of the capital with state-of-the-art security and an underground network of rooms and modern bunkers. He also had a vast farm on Airport Road in Tripoli.

**4. All newlyweds receive \$60,000 dinar (US\$ 50,000) by the government to buy their first apartment to help start a family.**

A well-known rumour and joke. While it may have been passed as official legislation, I know of not a single family given this grant which crippling bureaucracy makes them impossible to obtain.

**5. Education and medical treatments are free.**

**Before Gaddafi only 25% of Libyans were literate, today the figure is 83%.**

Free does not mean adequate. Libya's standard of healthcare is appalling; the majority of Libyans seeking medical care leave for neighbouring countries.

It is often said Libyans would be happy to forfeit their 'free health care' and pay for a national health service if it was up to standard.

The education system is outdated, teachers are underpaid and under-trained and libraries are almost non-existent. The syllabus was constantly being revised and reviewed under instruction from the former regime, such as banning English, changing Quranic verses, etc.

**6. Libyans wanting to take up a farming career received land, a farmhouse, equipments, seeds and livestock for free.**

This has never happened. Meanwhile many farms and homes have been confiscated by the government to build railroads, The Great Man Made River and civil roads.

The owners of the land were only compensated if it had a covered structure. Compensation was nowhere near the value of the property and many waited years to receive anything. A corrupt system saw many residents paying a bribe to receive the little they were given.

**7. If Libyans cannot find the education or medical facilities they need in Libya, the government funds them to go abroad and also gives \$2,300 a month accommodation and car allowance.**

If this was the case, the former regime would have been in receipt of six million application forms – one for every man, woman and child who 'cannot find education or medical facilities they need'. This grant does not exist for the public.

**8. If a Libyan buys a car, the government pays 50% of the price. The price of petrol in Libya is \$0.14 per litre.**

There is no truth with regards to a new car.

While fuel is cheap, the quality of roads, the accuracy and availability of road signs, the presence of road traffic police, and all other transport infrastructure is of abysmal standard.

The absence of an integrated, functional public transport system means people are reliant on their cars for all movement and might end up paying more on fuel than our Mediterranean neighbours.

**9. Libya has no external debt and its reserves amount to \$150 billion now frozen internationally.**

While sovereign wealth is undeniable, none of it was spent on the people or infrastructure. Basic amenities, services, and state infrastructure are either

absent or of appalling standard.

The Arabs have a saying about Libya – 'A rich nation of poor inhabitants'.

**10. If a Libyan is unable to get employment after graduation the state will pay the average salary of the profession until employment is found.**

False. Even basic wages are sometimes unpaid for months, for those lucky enough to be employed. Welfare for the unemployed is non-existent.

**11. A portion of Libyan oil sales is credited directly to the bank accounts of all Libyan citizens.**

False.

**12. A mother who gives birth to a child receives US \$5,000.**

False. There is a child benefit welfare payment of 15-20 Libyan dinars a month per child.

**13. Forty loaves of bread in Libya costs \$ 0.15.**

Bread is subsidised by the state and usually costs ¼ dinars for 10 small baguettes or roughly 500 grams per dinar.

**14. One in four Libyans has a university degree.**

The absence of a comprehensive selection process and a corrupt entry protocol means that universities are grossly overpopulated and oversubscribed, despite limited facilities. This results in too many graduates, but not necessarily an adequate level of employability. There are thousands of students studying foundation-year medicine in Tripoli alone.

**15. Gaddafi carried out the world's largest irrigation project, known as the Great Man-Made River project, to make water readily available.**

The jury is still out on this. The project has indeed supplied water to many towns and cities around Libya, but the cost is thought to be as stratospheric as the time it took to complete. Further, decades of an absence of appropriate licensing, monitoring and control has meant that wells were dug for every home, putting immense pressure on Libya's naturally-replenishable water sources. This resulted in the increase of salinity in local water reserves, which led to the need for an expansive project such as the man made river.

I have written this as a person with close ties to the country for more than 42 years. I have witnessed some of the points above, some with shock and horror. In a dictatorship, the people are never free.



# Half of Australia locked down as citizens told: ‘Don’t talk to each other’

**WHAT started as a two-week lockdown in Sydney at the start of July, has expanded to cover more than half of Australia’s 25 million people as of Tuesday 20th as a third state adopted the strict anti-covid measures as the ‘delta’-induced paranoia continued to swell.**

South Australia has ordered a ‘snap lockdown’ of (at least) seven days, joining neighboring Victoria and New South Wales, Reuters reported.

Even though Australia’s daily new covid cases and deaths are well below other developed nations, authorities started again with the lockdowns after its ‘drawbridge’ strategy failed to keep covid cases at the country’s insane target level of ‘0’. Now, they’re desperately trying to vaccinate as many Australians as possible during the coming weeks.

Premier Steven Marshall defended his decision to impose the lockdown measures, saying “we hate to put these restrictions in place, but we have just one chance to get this right”. The alternative, he suggested, would be a lengthier freeze. But as the lockdowns spread, the Australian people have grown increasingly irritated, and the politicians are taking notice as their polling numbers plummet.

Protests in Sydney on the

24th of July turned violent with police attacking marchers.

Under the rules of the new lockdown, all South Australian residents are required to remain at home unless they are essential workers or need to purchase groceries or other necessities, or attend medical appointments. Individuals are allowed outside to exercise for a maximum of 90 minutes and within a 2.5km (1.5 mile) radius of their home. Schools will be closed and students will transition to online learning.

The decision to impose a strict snap lockdown comes after just five covid cases were reported, with the fifth being an isolated incident from the other four cases.

“We are seeing more hospitalisations, more admissions to ICU, more people on ventilators - we have to stop the spread of covid,” Kerry Chant, the state’s chief health officer, said in Sydney, referring to intensive care units.

Ninety-five people with covid-19 have been hospitalised in Sydney, 27 of them in intensive care and 11 on ventilators. The state’s five deaths in the latest outbreak take the national toll to 915, with a tally of just over 32,000 infections.

Despite these very low figure, as of Tuesday, some 13 million Australians, over half of the country’s population, are under a stay-at-home mandate. Neighboring Victoria extended its lockdown until July 27. It was intended to last only five days when it was first implemented, yet new cases

continue to be found, and the draconian measures of command control continue to be imposed.

Australia’s covid numbers are tiny, so why the massive over-reaction from the government? Since early 2020, the country has recorded just over 32,000 cases and less than 1,000 lives lost to covid, officially. Given the way numbers have been inflated by governments and health departments across the world, the actual number is likely to be a lot lower too.

Furthermore, in what is clearly another push to dehumanise Australians, the chief health officer of New South Wales gave a press conference telling them that they shouldn’t “engage in conversation with each other,” even if they’re wearing masks, in order to reduce the transmission of covid.

“Whilst it’s human nature to engage in conversation with others, to be friendly, unfortunately this is not the time to do that,” said Chant.

“So even if you run into your next door neighbor in the shopping center... don’t start up a conversation, now is the time for minimising your interactions with others, even if you’ve got a mask, do not think that affords total protection, we want to be absolutely sure that as we go about our daily lives we do not come into contact with anyone else that would pose a risk,” she added.

Twilight zone doesn’t even come close.

## Cypriots denied groceries

**THE low rate of vaccination among young people aged 18 to 30 has prompted the Cypriot government to adopt new measures aimed at promoting and accelerating vaccination rollout, especially among young adults.**

At the forefront of the new measures is the ‘SafePass’ policy in place since July 9, whereby citizens aged 12 or older are obliged to possess and present either a vaccination certificate with at least one dose — including completion of a three-week post-vaccination period — or proof that a person has contracted covid-19 in the last 6 months, or a negative PCR or rapid test with a 72-hour validity period.

The SafePass must be presented by employees and customers entering an establishment, be it their workplace, a restaurant or bar. In addition, the provision of free rapid antigen tests will be abolished as of August 1 in an effort to exert pressure on unvaccinated citizens either to get vaccinated or pay for a PCR or rapid test every 72 hours.

Stefanos Athanasiou, owner of ‘Feggaraki’, a souvlaki restaurant, and ‘Madame’, a cocktail bar at the heart of Limassol, explained the difficulties he experienced while implementing this new measure. “We find ourselves in the difficult position of carrying out checks, without any guidelines from the government. We are essentially doing the government’s job”.

He added that “checking our customers’ personal data goes against the ‘mission’ of food service establishments, which is hospitality and entertainment. We had to turn people away because they didn’t have a SafePass.”

## Lisbon Court rules only 152 ‘verified cases’ died of covid

**THE Lisbon court has ruled that only 0.9% of ‘verified cases’ died of covid-19, totalling 152, instead of the 17,000 claimed by the faked government covid death statistics.**

Following a petition started by a citizen, a court in Lisbon was forced to provide verified data on covid-19 mortalities.

The documents revealed that the number of verified covid-19 deaths from January 2020 to April 2021 is only 152, a drastically lesser number than the 17,000 deaths claimed by the government.

The data is from the Sistema de Informação dos Certificados de Óbito (Death Certificate Information System – SICO) in Portugal.

All the other deaths appear to be as a result of unrelated reasons, with many of those listed having tested positive on PCR tests, again, suggesting that the tests are completely unreliable.

Kary Mullis, the inventor of the PCR test, previously stated the results can be interpreted to create the illusion of a pandemic.

Many covid tests have high cycle thresholds – most are set to 37 or 40 – meaning that there are a large number of false positives.

This news comes as a number of large lawsuits are set to take place against those responsible for the covid deception and pushing the vaccine agenda which has caused serious adverse reactions and even death, including one launched in the U.S. state of Alabama on behalf of America’s Frontline Doctors.

# Study links acute chest pain in U.S. soldiers to mRNA vaccines

**MALE soldiers in the U.S. have been struck by sudden acute chest pains following covid-19 shots.**

Previously, we told of rare cases of heart inflammation linked to the mRNA Covid jabs, including the jabs from Pfizer-BioNTech and Moderna.

After a hurried secret meeting with its advisory board on vaccine safety, the FDA issued a warning asking patients experiencing these symptoms to seek help immediately.

The latest study, published in JAMA’s Cardiology Journal, showed that 23 male soldiers (including 22 deemed ‘previously healthy’) between

the ages of 20 and 51 presented ‘acute onset of marked chest pain’ within four days of receiving their second dose.

Patients who sought care for chest pain in the military health-care system following covid-19 vaccination and were subsequently diagnosed with clinical myocarditis were included in the case study.

All those who tested for myocarditis, a condition that causes the swelling of the heart muscle and can cause difficulty breathing, heart failure and death, were ‘physically fit by military standards and lacking

any known history of cardiac disease, significant cardiac risk factors, or exposure to cardiotoxic agents’.

All patients in the study underwent electrocardiography and echocardiography tests. Abnormal electrocardiography findings were recorded in 19 (83%): findings included ST-segment elevations, T-wave inversions, and non-specific ST changes. Echocardiography in four patients (17%) demonstrated reduced left ventricular ejection fractions (40% to 50%).

The cardiac symptoms faded within a week of onset for 16 patients, while seven others continued to have chest discomfort.

As one table from the study showed, the number of cases of heart inflammation reported in the military is much higher than the rate that one might expect given population-wide incidence of these symptoms. This suggests some new variable is likely causing the surge in cases.

The study’s authors concluded that while the overall risk for patients who received an mRNA vaccine remains small, the U.S. is not alone in discovering these cases.

Israel, which also relied mostly on mRNA vaccines to inoculate its population, is also seeing surprisingly high incidence of heart inflammation likely linked to the vaccines.

Also, an experiment (in the guise of combatting fake global warming) part funded by Bill Gates, intends to send calcium carbonate into the stratosphere to dim the sun, which will then further help to destroy traditional farming.
- More untested experimental jabs will be made mandatory. There's a plan to vaccinate sick children – the ones most likely to be killed by the jab.
- Poverty is on the rise. As inflation soars (in the USA it is now already believed to be between 5% and 10% and soaring) so the rich will get richer and everyone else will get poorer.

# Reckless energy policy could lead to more blackouts - industry expert

**A RECKLESS fixation with greening the UK's power supply has left the country facing energy shortages and ever-increasing consumer costs.**

Last November, an article in the Times indicated how National Grid could expect electricity supply to increase from 110GW at present to between 145GW and 180GW by 2030.

State policy is for that extra 70GW to come largely from offshore wind. Replicating previous nationalised investment is not an option. As a consequence of going into Europe, project teams were disbanded, skilled personnel retired and a manufacturing base greatly reduced.

By necessity, nuclear investment is clearly the future direction for the UK if the residual legacy of our national manufacture can be harnessed towards a power station programme with the aim of self-reliance.

This direction has already been indicated with the Hinkley Point contract from EdeF having dated technology. However many uncertainties remain, not least the time scale involved with such a huge project.

What should be of concern is the existing nuclear Advanced Gas-cooled Reactor portfolio of seven power stations. The one at Hunterston is soon expected to retire, having been operating at reduced load for the last decade. When sold from British Energy to EdeF in 2008, the prospectus gave closure dates ranging from 2014 to 2023. These dates matter as two-thirds of the 29GW of coal capacity has been withdrawn, leaving the refurbished nuclear portfolio to provide the bulk of that energy shortfall to support the grid system. Wind, solar and interconnection are all connected through power electronics and give no guaranteed stored back-up.

Circumstances could have been different had certain private initiatives been supported by the state, with coal projects at Hunterston and Kingsnorth and a successor nuclear station to Sizewell approved as intended. Instead the state has been led into a blind alley, with the promise of renewable salvation, following a prolonged and increasingly frenzied media campaign.

New nuclear technology in Small Modular Reactors (SMR) has promise whereby suggested modules of 470MW can be factory made and installed at site in a fraction of the time taken by its dated cousin. The UK has some expertise in this field,



although progress is reliant on orders to decide locations, with the intent to power ten reactors by 2030. Critically, unlike its dated cousin, it could 'load follow', ie be dispatchable overnight.

Wind power is our albatross. A major consequence of renewable investment has been the scale of supporting transmission, together with a significant proposed interconnection to Europe at 10GW. Power generated must go somewhere, it cannot be spilled. If demand on the GB grid system is insufficient then exporting by undersea cables (unreliable and with the high risk of extended outage) is the only option apart from expensive and limited pumped storage.

At times of excessive wind output, heavy expense arises with constraint payments for any instructed shutdown. This is especially so overnight in summer when system demands have been down to as low as 18GW that would then face the hazard of rising solar output. Adding to this problem is the escalating cost of electricity where the attempt to force the use of heat pumps in place of gas will meet serious opposition.

Petrol and diesel car manufacture has been proscribed from 2030 to

stimulate further demand, and removing competition will embed dependency on the brittle nature of electricity supply.

Demands are already much lower than a decade ago because of rising bills, so overheads inevitably must be met from a smaller base. With state policies to spend, escalating costs can only continue.

Electricity bills have trebled since the millenium, doubling over the past decade. A radical solution being proposed by the Global Warming Policy Foundation is the removal of all subsidies from consumer bills with their costs being transferred into general taxation. These set of conditions are a reckless scenario. It can be understood as to why such an enormous investment has been made into smart metering whose essential purpose is to control demand by disconnection.

The effect of losing frequency control is to invite grid system instability. The risks of failure are enormous, given the time scales involved with supply, from excessive wind investment, interconnection failure and grid instability from insufficient guaranteed energy sources. We would become beholden to the EU with the sword of Damocles above

our heads. All leverage for export and imports would be lost, especially from an increasingly authoritarian neighbour.

Having flouted the vital principle of a generation mix, what should be our Plan B? Currently, heavy reliance is being placed on the capacity market in order to maintain adequate plant margins over the winter period. This solution will become less reliable and only serves to delay the need for new dispatchable capacity.

Another uncertainty is the expected fundamental change to National Grid. This syndicate is where all expertise with system security is concentrated and any error of judgement would have considerable repercussions. The structure that eventually emerges should have as a critical qualification its independence from government.

The precarious position we find ourselves in has been in part due to relinquishing our sovereignty to the EU, but the real damage has come from the enduring scale of subsidies for very costly 'green' energy sources over a decade being inflicted onto the consumer thereby avoiding scrutiny by parliament.

Many problems could have been foreseen with more transparency

and commercial discipline. The GWPF recently calculated that energy subsidies cost each household £350 last year and will rise by £25 annually. In addition, the cost of managing the grid system comes to £65 per year for each household, and will rise £20 per year, not to mention the cost of grid upgrades.

Lord Lawson, GWPF director, warned: "We are in the middle of an economic crisis and consumers are hit with astronomical costs for unreliable wind energy. These multi-billion pound subsidies are not only a massive transfer of wealth from the poor to the rich but are damaging the UK economy as a whole. This madness has to stop".

Finally, the UK saw an anti-cyclone lasting almost three weeks in April with a wind contribution of around 1 to 3GW from a 25GW portfolio. Over that period there appears to have been at least two outages from the three continental interconnections.

Had it been mid-winter, we would probably have had disruption to supplies. Last winter there were four warnings from National Grid of insufficient supply capacity, a situation not experienced over the previous four years.

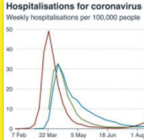
### 3. Impose Lockdowns

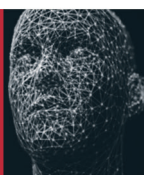
### 11. Impose Human Nanochipping
